Chair and Members:

Your Economic Development and Budget Committee, having met on October 7, 2020, makes reference to County Communication 20-416, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.27, MAUI COUNTY CODE, RELATING TO A VEHICLE DISPOSAL FEE FUND."

The purpose of the proposed bill is to correct an erroneous reference in Chapter 3.27, Maui County Code, which was established by Ordinance 5096, effective June 15, 2020. The bill would amend Section 3.27.030(B), Maui County Code, to clarify that deposits to the Vehicle Disposal Fee Fund may be only used for the purpose stated in Section 3.27.020.

Your Committee notes the Vehicle Disposal Fee Fund is intended to be used "solely for the purpose of providing funding for the County vehicle disposal program, which simplifies the process for residents to properly dispose of their unwanted vehicles," as stated in Section 3.27.020.

Your Committee voted 9-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Rawlins-Fernandez, Vice-Chair King, and members Hokama, Kama, Lee, Molina, Paltin, Sinenci, and Sugimura voted "aye."

A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.27,
MAUI COUNTY CODE, RELATING TO A
VEHICLE DISPOSAL FEE FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.27.030, Maui County Code, is amended to read as follows:

“3.27.030 Deposits to the fund and use. A. There shall be deposited into the fund all fees collected from vehicle owners for vehicle disposal.

B. The revenues in this fund shall not be used for any purpose except for those listed in section [3.26.020.] 3.27.020.

C. The department of finance shall be responsible for the management of this fund.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance takes effect upon its approval.
