PROBLEM STATEMENT

MPD DISTRACTED DRIVING HIGH VISIBILITY ENFORCEMENT

Grant No: DD21-M-03

Identify the traffic safety related problem or deficiency that the proposed grant is intended to correct.

PROBLEM STATEMENT - Driving is a multi-tasking operation that involves manual, visual, and cognitive tasks. Distracted driving is defined as any non-driving activity a person engages in that has the potential to distract him or her from the primary task of driving and increases the risk of crashing.

The percentage of passenger vehicle drivers text-messaging or visibly manipulating handheld devices remained constant at 2.2 percent in 2015. Driver handheld cell phone use decreased from 4.3 percent in 2014 to 3.8 percent in 2015; this was not a statistically significant decrease. The 2015 NOPUS found that handheld cell phone use continued to be higher among female drivers than male drivers. It also found that handheld cell phone use continued to be highest among 16- to 24-year-old drivers and lowest among drivers 70 and older

Drivers who use hand-held devices are four times more likely to be involved in a crash serious enough to injure them. (Source: Insurance Institute for Highway Safety). Using a cell phone while driving, whether it is hand held or hands-free, delays a driver's reaction as much as having blood alcohol concentration at the legal limit of .08 percent (Source: University of Utah).

The 2019 Hawaii Seat Belt Survey, conducted by the University of Hawaii at Manoa during winter 2019, showed that the statewide daytime cell phone use rate decreased from .98 % from the summer 2018 observations to .92 % in January 2019.

GRANT GOALS - Maui Police Department's (MPD) goals in FFY 2021 are to achieve the following:

- 1. Increase voluntary compliance of distracted driving laws by making 1,250 Mobile Electronic Device (MED) related contacts, which includes MED related citations and/or educational contacts "teaching moments," issued by September 30, 2021, as compared to 1,599 citations for FFY 2020;
- 2. Enhance electronic mobile device use enforcement by maintaining 560 hours (same as FFY 2020) for officer's overtime to make 1,250 Mobile Electronic Device (MED) related contacts which include MED related citations and/or educational contacts "teaching moments;" by September 30, 2021;
- 3. Continue with electronic mobile device use enforcement activities on state and county roadways where there is a high volume of vehicular traffic in FFY 2021; and
- 4. Conduct 60 hours of in person education at traffic safety events to promote voluntary compliance of MED related laws by September 30, 2021, compared to 56 hours for 2019.

Personnel Costs - The Maui Police Department (MPD) will conduct active and aggressive enforcement of the Distracted Driving law using grant funds for after-hours (overtime) funding of officers (560 hours). Cost is based on an average overtime rate using a Police Officer 9/L3 at the overtime rate of \$67.91 plus an estimated fringe rate of 76.19%. Total OT rate is about \$119.64 per hour. This rate of pay is based on the average officer participating and that some officers will have a lower/higher pay rate. MPD will participate in the National Distracted Driving Awareness Month in April 2021. MPD officers will conduct two or more traffic safety events using 60 hours of overtime. They will distribute flyers, pamphlets, or participate in sign waving events regarding the prohibited use of electronic mobile devices, Seatbelt usage, or impaired driving awareness. Hand out materials will be provided by HDOT.

THIS AGREEMENT made and entered into by and between the STATE OF HAWAII by and through its Director of Transportation, hereinafter referred to as "State," and the Governmental Unit named in this application, hereinafter referred to as "Applicant."

WHEREAS, the National Highway Safety Act of 1966 (Public Law 89-564) provides Federal funds to the STATE for approved highway safety projects, and

WHEREAS, STATE may make said funds available to various state, county or municipal agencies or governments or political subdivisions upon application and approval by STATE and the UNITED STATES DEPARTMENT OF TRANSPORTATION, and

WHEREAS, STATE is obligated to reimburse the UNITED STATES DEPARTMENT OF TRANSPORTATION out of its funds for any ineligible or unauthorized expenditures for which Federal funds have been claimed and payment received, and

WHEREAS, the above name APPLICANT has submitted an application for Federal funds for highway safety projects.

NOW, THEREFORE, IN CONSIDERATION OF MUTUAL PROMISES AND OTHER GOOD AND VALUABLE CONSIDERATION, THE PARTIES AGREE AS FOLLOWS:

GENERAL REQUIREMENTS

The APPLICANT will comply with applicable statutes and regulations, including but not limited to:

- •23 U.S.C. Chapter 4 Highway Safety Act of 1966, as amended
- •Sec. 1906, Pub. L. 109-59, as amended by Sec. 4011, Pub. L. 114-94
- •23 CFR part 1300 Uniform Procedures for State Highway Safety Grant Programs
- •27 CFR part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards
- •2 CFR part 1201 Department of Transportation, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards

NONDISCRIMINATION

The APPLICANT will comply with all Federal statutes and implementing regulations relating to nondiscrimination ("Federal Nondiscrimination Authorities"). These include but are not limited to:

- b. Not to participate directly or indirectly in the discrimination prohibited by any Federal nondiscrimination law or regulation, as set forth in appendix B of 49 CFR part 21 and herein;
- c. To permit access to its books, records, accounts, other sources of information, and its facilities as required by the State highway safety office, US DOT or NHTSA;
- d.That, in event a contractor/funding recipient fails to comply with any nondiscrimination provisions in this contract/funding agreement, the State highway safety agency will have the right to impose such contract/agreement sanctions as it or NHTSA determine are appropriate, including but not limited to withholding payments to the contractor/funding recipient under the contract/agreement until the contractor/funding recipient complies; and/or cancelling, terminating, or suspending a contract or funding agreement, in whole or in part; and
- e. To insert this clause, including paragraphs (a) through (e), in every subcontract and subagreement and in every solicitation for a subcontract or sub-agreement, that receives Federal funds under this program.
