BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5099, Bill No. 64 (2020), Draft 1, as amended, "Fiscal Year 2021 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2021, is hereby amended by adding the Office of the County Clerk, and a new grant in the amount of \$130,456, entitled "Center for Tech and Civic Life Grant," to read as follows:

"13. Department of Water Supply

a. State of Hawaii, Department of Land and Natural Resources 1,000,000

a. State of Hawaii, Kanaha Beach Park Greywater Reuse Demonstration Project 450,000

14. Office of the County Clerk

a. Center for Tech and Civic Life Grant 130,456

[14] 15. Additional Revenues Received Pursuant to the Foregoing Grants 500,000"
