1. "Actual Scale" Covid-19 Virus Chart-

The contagious period is only 3,4 or 5 days according to DR Michael Mina.

2. Most important factor in protecting the people of Hawaii from Covid-19?

Being able to INDENTIFY TOURISTS WHO ARE ACTIVELY CONTAGIOUS at the airport and being able to remove them and isolate them, treat them and then release them once they are not contagious.

(3, 4 or 5 days isolation until NOT CONTAGIOUS) NOT 14 DAYS

SO THAT THE TOURISTS THAT ARE CLEARED ARE ABLE TO ENJOY THEIR VACATION AND SPEND MONEY IN HAWAII.

3. Rapid testing 75% of a city every 3 days could 'drive the epidemic toward extinction' within 6 weeks, a new study claims. Slovakia did it!

In 3 weeks, 50% of population tested 3 times, 80% reduction in cases.

Now, Austria, Poland, UK, Cameroon, India and South Korea.

South Korea just started 5 days ago;

- 4. Rapid Antigen COVID Testing vs. current practice PCR COVID Testing (up to 70% PCR positive cases NOT CONTAGIOUS) (DELAYING TOURISTS FROM VISITING)
- 5. Reopening our economy & containing spread thru quick-result testing-BRING LIFE BACK TO NORMAL/LET PEOPLE SPEND MONEY AND MAKE MONEY
- Surveillance testing and Entrance Testing 10 to 30 min prior entering any location.

## **PLAN OF ACTION**

- 7. <u>Tourists</u>- Replace expensive, slow PCR testing with 10 min Rapid Antigen Testing- Save Money, Much More Effective.
- A. Test before boarding the plan, from departing state
- B. Test deplaning in Hawaii
- C. Test 1 time every week they stay on their vacation.
- D. Even up to 5, 6 or 7 testing still cheaper than 1 PCR test.
- E. Tourist Program can Self Fund itself
- F. Setup testing stations of rapid antigen testing at the airport, separate from busy sections of the airport.
- G. Text <u>Certificate of Clean Health</u> to each tourist on their phone after negative testing with date of test and when the next testing is required.

- 1. Test 1 time Every Week
- 2. Rapid deployment of many temporary Kiosk testing sites, especially in areas where Covid-19 is exploding.
- 3. Text Certificate of Clean Health to each resident on their phone after negative testing with date of test and when the next testing is required.
