SUPPORTING LEGALIZING, REGULATING, AND TAXING RESPONSIBLE, ADULT-USE CANNABIS

WHEREAS, cannabis is the scientific name for a plant genus often referred to colloquially as marijuana; and

WHEREAS, Hawai'i residents and public officials increasingly recognize the importance of cannabis as a growth industry; and

WHEREAS, as reported in *Business Insider* on January 6, 2021, "Marijuana is legal for all adults in 11 states, and for medical purposes in 34"; and

WHEREAS, growth in the cannabis industry has the potential to diversify the County's economy and reduce its reliance on the tourism industry; and

WHEREAS, the Controlled Substances Act of 1970 does not recognize the difference between medical and recreational use of cannabis, and both remain illegal under Federal law; and

WHEREAS, the State Legislature legalized cannabis for medical use in 2000, but recreational use remains illegal; and

WHEREAS, according to the Colorado Department of Revenue, it has collected \$1.6 billion in revenue in marijuana excise tax since 2014; and

WHEREAS, the Marijuana Policy Project reported: "As of November 2020, states reported a combined total of \$6.59 billion in tax revenue from legal, adult-use marijuana sales"; and

WHEREAS, in November 2016, President Barack Obama said he would like to treat cannabis "as a public-health issue, the same way we do with cigarettes or alcohol" and called the patchwork of state and federal laws regarding the drug "untenable"; and

WHEREAS, the Applied Health Economic and Health Policy journal reported on January 25, 2021, that the enactment of marijuana

legalization in Canada preceded a "marked decline" in the volume of opioids prescribed to patients enrolled in both public and private health care plans; and

WHEREAS, the State legislature enacted Act 273 (2019), with the following stated purposes:

- "Provide for the expungement of criminal records pertaining solely to the possession of three grams or less of marijuana;"
- "Decriminalize the possession of three grams or less of marijuana and establish that such possession of that amount is a violation punishable by a monetary fine of \$130;" and
- "Establish a marijuana evaluation task force to make recommendations on changing marijuana use penalties and outcomes in the State"; and

WHEREAS, Act 273 did not include treatment-program language; and

WHEREAS, an American Civil Liberties Union report last year, "A Tale of Two Countries: Racially Targeted Arrests in the Era of Marijuana Reform," found:

- marijuana arrests were still widespread across the country;
- extreme racial disparities in marijuana possession arrests persisted throughout the country;
- marijuana arrests decreased after legalization or decriminalization;
- racial disparities in arrests persisted even in states that legalized or decriminalized marijuana; and
- data-collection failures blocked a fuller understanding of racial disparities in marijuana arrests; and

WHEREAS, convictions for small amounts of cannabis can result in punitive collateral consequences, disproportionately affecting people of color; now, therefore, BE IT RESOLVED by the Council of the County of Maui:

- 1. That it supports legalizing, regulating, and taxing responsible, adult-use cannabis;
- 2. That it supports granting clemency or resentencing to anyone incarcerated on a cannabis conviction and expunging all cannabis convictions;
- 3. That it supports investing in nonpunitive programs and community-based services and divesting from law enforcement;
- 4. That it supports treating cannabis as a public-health issue;
- 5. That it supports the creation of a Hawai'i cannabis control board; and
- 6. That certified copies of this Resolution be transmitted to the Honorable Mazie K. Hirono, United States Senator; the Honorable Brian E. Schatz, United States Senator; the Honorable Kaiali'i Kahele, United States Representative; the Honorable Scott Saiki, Speaker, Hawaii State House of Representatives; the Honorable Ron Kouchi, President, Hawaii State Senate; Maui County's delegation to the State Legislature; the Honorable David Y. Ige, Governor, State of Hawaii; and the Honorable Michael P. Victorino, Mayor, County of Maui.
