Notes:

2.28.060 (B) (1)

The intention is that the advisory committee members know the community well, and represent the people that live in the community. Is 90 days of residency in the community plan district sufficient to "know" and "understand" the community? I don't believe it is.

2.28.060 (B) (4)

"To promote geographic diversity there shall be no more than three members from the same town on the committee".

Is Huelo a "town", or is it a section of Haiku? If Spreckelsville is included with Paia/Haiku is that a town, or again, is it part of Paia? With only three members from each "town", Paia/Haiku might only have six advisory committee members.

2.28.060 (D) (1) (c)

I've never heard of "Stage Road". Perhaps it's "Stable Road"?

Are the issues for Spreckelsville the same as the issues for Paia / Haiku? Wouldn't their main issue be the airport which is more closely aligned with the issues of Kahului Wailuku?

2.28.070 (B)

"At least one member of each advisory committee must be a third-generation resident of that advisory committee's assigned area".

This raises questions – does it require that all three generations had residence in Paia/Haiku? What if the 1st generation lived in Paia/Haiku, but the second generation lived in Lahaina, and now the third generation is living in Paia/Haiku? The current wording dictates that all THREE generations had to live in Paia/Haiku. For how long? What if they went away to college? What if they only lived in Paia/Haiku for a few years?

2.28.070 (C)

"In making appointments to each advisory committee, the council and the mayor should strive for diversity and balance of age, gender, background, profession, heritage, experience and ideology." This should be more specific. If the committee is to review all proposals for the Paia/Haiku area, I am assuming the main area of interest is development. It wouldn't be fair to have a housing development reviewed by 7 members that already own their properties. The committee should include both homeowners and renters. They might have opposite opinions, but they are all members of the community.

IS THERE A NEED?

I took a look at all of the planning commission agendas for 2018, 2019, and January 2020. Below is a summary and the detail follows. Does this number of items justify another layer of government? Perhaps a better solution is to have the Planning Commission meet in Paia/Haiku when they are hearing an item that is important to the Paia/Haiku area. This would be similar to the council visiting Molokai to hear several Molokai items. I felt that was an excellent idea, and should be utilized more frequently.

Note: this applies to Paia/Haiku only. For the Kihei area, they had important items on almost every agenda.
