'BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5099, Bill No. 64 (2020), Draft 1, as amended, "Fiscal Year 2021 Budget," Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2021, is hereby amended as it pertains to the Department of Environmental Management, by adding a new grant entitled "State of Hawaii, Department of Defense Hawaii Emergency Management Agency (HI-EMA) Grant" in the amount of \$633,750, to read as follows:

"2. Department of Environmental Management

a. Electronics Program	400,000
b. Glass Recovery Program	120,000
c. Recycling Program - Landfill Diversion	300,000
d. West Maui Recycled Water System Expansion – Honua Kai, Hyatt, and Starwood	2,421,710
<u>e. State of Hawaii, Department of Defense Hawaii Emergency Management Agency (HI-EMA) Grant</u>	<u>633,750"</u>
