SUBJECT: AMENDMENT TO THE FISCAL YEAR ("FY") 2021 BUDGET (HOME ACQUISITION AND OWNERSHIP PROGRAMS REVOLVING FUND)

On behalf of the Department of Housing and Human Concerns, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2021 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2021, HOME ACQUISITION AND OWNERSHIP PROGRAMS REVOLVING FUND."

The purpose of the proposed bill is to amend Appendix A, Part II of the FY 2021 Budget as it relates to the Home Acquisition and Ownerships Programs Revolving Fund ("Fund") by adding a proviso to allow for the disbursement of grants, up to \$30,000, for Maui County residents participating in the First-time Homebuyers Down Payment Assistance Program.

Ordinance 5180 amended Appendix A, Part II of the FY 2021 budget as it relates to the Fund by adding anticipated revenues of \$1,672,374. The proviso to allow for disbursements from the Fund was inadvertently not included in the amendment.

## BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1.
