I am in receipt of an email inquiry from Diane Wakamatsu of Council Chair Alice Lee's Office (attached as Exhibit "1") and provide the following response:

  - The Carryover/Savings, by fund is provided on page 1 of the Budget Ordinance. Please see highlighted section on the attached Exhibit "2".
- 2. Please verity that the estimated total dollar amount for the Highway Fund is \$79+ million, of which the Department of Public Works would expend \$41 million, and the Department of Transportation would expend \$38 million. Also, please identify where the appropriations that match up to these dollar amounts (for programs, activities, etc.) is located in the FY 22 Budget (specifically, the page number of what budget document)?

The total estimated revenue for the Highway Fund for FY 2022 is approximately \$79 million (see page 67 of the Program Budget Book).

The Department of Public Works is allocated approximately \$33.0 million for salaries, operations, and equipment (see page 17-39 and 17-40 of the Budget Details). They also have approximately \$38.4 million in Capital Improvement Projects funded by General Obligation Bonds and the Highway Fund (see page 730 of the Program Budget Book).

The Department of Transportation is allocated approximately \$7.9 million from the Highway Fund for salaries, operations, and equipment (see page 18-11 of the Budget Details).

# A BILL FOR AN ORDINANCE RELATING TO THE OPERATING BUDGET FOR THE COUNTY OF MAUI FOR THE FISCAL YEAR JULY 1, 2021 TO JUNE 30, 2022

#### BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. This ordinance may be referred to as the "Fiscal Year 2022 Budget."

SECTION 2. The several amounts listed below are declared to be estimated revenues of the County of Maui for the Fiscal Year July 1, 2021 through June 30, 2022, and are appropriated to the functions, programs, funds, departments, and agencies for the purposes set forth in Sections 3 and 4.
