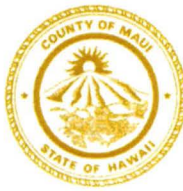

**SUBJECT: FISCAL YEAR ("FY") 2022 BUDGET (BFED-1)**

As it relates to the Department of Public Works, I am transmitting information relating to the Lahaina Flood Protection Project. The Department will be receiving \$1,229,230 from the United States Department of Agriculture Natural Resource Conservation Service for the project.

The project is necessary to alleviate flooding in Lahaina Town. The flood control system is intended to divert floodwaters from watershed areas south of Lahainaluna Road to the existing outlet near Puamana Park.

To add the project to the FY 2022 Budget, the following revisions are needed:

1. Amend Appendix A, Part I by adding an appropriation entitled "USDA Natural Resource Conservation Service – Lahaina Watershed Flood Protection Project" for \$1,229,230.
2. Amend Appendix C, Department of Public Works, West Maui Community Plan Area by adding the following: "CBS-1026", "b. Lahaina Watershed Flood Protection Project", "\$1,229, 230", and

adding a project description to read, "To conduct an environmental and planning study to review the existing project plans, examine the existing drainage conditions in the watershed, evaluate the project need and feasibility, develop design alternatives, conduct stakeholder and public outreach, select a design alternative, and produce a final report that will support the next phase of the project."

3. Amend the Capital Program Bill by adding the drainage project under the West Maui Community Plan Area and updating totals accordingly.
4. Create a project sheet for CBS 1026, Lahaina Watershed Flood Protection Project.
