The Department must present the plan for emergency funding use and a plan for cost recovery from the property owners of the Kaupakalua Reservoir, East Maui Irrigation and Mahi Pono, to the Council by the Department prior to the work commencing and provide the Council annual financial and performance reports on the funding."
