RELATING TO THE APPOINTMENT OF ERIC CUOMO TO THE COST OF GOVERNMENT COMMISSION

WHEREAS, by correspondence dated April 30, 2021, Mayor Michael P. Victorino notified the Council he nominated Eric Cuomo to the Cost of Government Commission for a term expiring March 31, 2023, to fill a vacancy replacing Hannah Werth, in accordance with Sections 3-9.3 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it approves the appointment of Eric Cuomo to serve on the Cost of Government Commission for a term expiring March 31, 2023;
- 2. That the Council expresses its gratitude and appreciation to Eric Cuomo for his willingness to be considered for public service and actively participate in County government; and
- 3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
