Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on June 1, 2021, makes reference to County Communication 21-42, from Council Chair Alice L. Lee, relating to nominations to boards, committees, and commissions.

By correspondence dated April 21, 2021, and received on April 22, 2021, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF KAULANA MOSSMAN TO THE LIQUOR CONTROL ADJUDICATION BOARD FOR THE COUNTY OF MAUI," with a completed application for the nominee.

The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Kaulana Mossman to the Liquor Control Adjudication Board, for a term expiring on March 31, 2023, to fill a vacancy due to the resignation of Herman Nascimento.

Your Committee notes general appointment procedures for boards, committees, and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code.

Your Committee further notes specific provisions for the Liquor Control Adjudication Board are located in Section 2.41.080, Maui County Code, and Charter Section 8-13.3.

The Council must approve or disapprove the nomination by June 21, 2021, or the nomination will be deemed approved.

Your Committee discussed the nomination.

A representative from the Office of the Mayor said Mr. Mossman is a County firefighter, who also has experience in real estate, agriculture, and the food and beverage industry. He is also president of the Keokea Agricultural Homestead Lots.

Your Committee notes Mr. Mossman previously served on the Liquor Control Adjudication Board from May 2013 to March 2016.

Your Committee agreed his prior board experience and commitment to serving the community would be an asset.

Your Committee was satisfied with the nomination and recommended Mr. Mossman be approved.

Your Committee voted 9-0 to recommend adoption of a proposed resolution approving the nomination. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Johnson, Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye."

WHEREAS, by correspondence dated April 21, 2021, Mayor Michael P.
