- Vaccine coordination

- Testing
- Contact Tracing
- Monitor County Metrics
- Visitor Education
- Homeless COVID19 prevention
- Hospital advisory and support
- PPE coordination
- Advocacy for at risk populations
- Multigenerational home support

### Smart Ideas and Best Practices come together

- Collaboration between Counties, State and Experts
- Regular evaluation of what is working and what is not
- Implement proven ideas and plans that have worked elsewhere
- More consistent response to COVID19
- Better proactive plans to prevent community spread
- An established way for ideas to quickly become a reality
- Boots on the ground to get things done
- Get rid of blame shifting and finger pointing "that is not our job" mentality
- Slowing the spread and preventing COVID19 is the Task Force "job" and responsibility (as long as they are given the authority to do it)
- Use federal money on prevention of COVID19
- Get needed resources (state, federal, public)

# Task force would be a bridge between decision makers and the COVID19 front lines

Regular communication and reports to connect the Mayor and Governor with the reality of what is happening and being seen by essential and frontline workers and concerned citizens. Task force can meet with groups to gather information from:

## Schools- coordination between county, DOE, BOE and DOH

- Need outdoor shaded areas so that more school time can be spent outdoors where COVID19 is least likely to spread
- Sanitization of high touch surfaces
- Education for Principals and Teachers about best practices
- How and when to do mask breaks
- Most ideal ventilation for indoor areas
- Notification of a positive case and rapid contact tracing plans
- Virtual learning support
- Required absences planning

#### Businesses - coordination between county and DOH

- Best Practices
- Evaluations
- Planning for scenarios
- Assistance with enforcement
- Rapid contact tracing plan
- Testing plan
- PPE assistance
- Sanitization assistance
- Ventilation assistance

## Mask mandate coordinate with LEO, county, DOH, and state

- Public Education
- Signage and flyers
- Evaluate if it is working
- Track compliance
- Does mandate align with current conditions
- Common Sense approach
- Does the penalty match the offense
- Provide masks to people who cannot obtain easily or afford
- Smart enforcement

# Gatherings coordination with public, LEO, and county

- Huge Public Education campaign
- Assume people will gather establish "safest" practices
- Evaluate current cases and establish max gathering size
- Eliminate double standards
- Strict rules for exceptions and "larger" gatherings
- Evaluate and establish penalty for non-compliance
- Provide free and easy to use alternatives

#### Quarantine

- Plan that will guarantee higher rate of compliance
- Enforcement
- Digital tracking
- In person check-ins (on phone or on site)
- Meal coordination
- Designated facilities

## **Testing**

- How available is it?
- Does the public know about it?
- Evaluate how we are doing and how to improve
- Surveillance testing for at risk workers and citizens
- Positivity rate driven
- Procure more for the county
- Incentivize testing in certain industries and sectors

### **Contact Tracing**

- Establish a county based team
- Have a digital and human system
- Increase usage by public and visitors of digital systems
- Evaluate how quickly is it being done
- Share data with the public where are the cases coming from
- Follow up with cases
- Decrease time taken to contact trace
- Establish best practices
- Have a training system in place to have more available quickly

## **Monitor County Metrics**

- Establish or evaluate county metrics
- Track cases and hospitalizations to know when we can loosen or tighten restrictions
- Make metrics widely available and well understood
- Get community buy in- We are all in this together. All do our part to stay open
