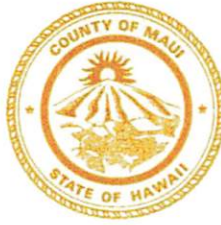

This letter is a notice of the State of Hawaii's intent to award the County of Maui (County) Department of Housing & Human Concerns, a contract in the amount of \$864,200.00 to develop and administer the Kahului Affordable Housing for Homeless Families (KAHHF) Program on the island of Maui, for the period beginning June 15, 2019 through June 14, 2022. This letter reflects both parties intent to enter into this contract. The award is conditioned upon the execution of a contract that has been sent to the County for review and approval.

The notice of award is issued as the first step in the award and contracting process. Upon final execution of the contract a copy will be forwarded to you, and the County will be eligible for reimbursement for costs incurred on and following the contract start date and through the contract period, subject to the contract terms.

Invoices submitted for payment will be subject to the State's review and approval. The State reserves the right to reject any invoice for payment if the costs incurred are not eligible per the contract terms.
