## A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.48, MAUI COUNTY CODE, RELATING TO KULEANA LAND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.48.554, Maui County Code, is amended by amending Subsection A to read as follows:

"A. [Those] <u>Notwithstanding any other provision of this chapter, those</u> portions of real property designated as kuleana land[, shall be] <u>are</u> exempt from paying real property taxes, <u>delinquent taxes</u>, and <u>penalties</u> if:

 The property is owned in whole or in part by a lineal descendant of the [person(s)] <u>person</u> who received the original title to the kuleana land;

2. The portion of property designated as kuleana land is not used for commercial purposes; and

3. An application for exemption is filed with, and approved by, the director."

SECTION 2. Section 3.48.140, Maui County Code, is amended to read as follows:

"Except as specifically provided in this chapter, no changes in, additions to, or deductions from the real property tax assessments on the assessment lists prepared as provided in section 3.48.135 [shall] <u>may</u> be made except to add [thereto] property or assessments [which] <u>that</u> may have been omitted [therefrom], or to deduct [therefrom] adjustments on account of duplicate assessments and clerical errors, such as transposition in figures, typographical errors, and errors in calculation. <u>If kuleana land classification is granted, the</u> <u>portions of real property designated as kuleana land will be listed as exempt</u> <u>on the assessment lists, and all delinquent taxes and penalties must be</u> <u>removed from the portions of real property designated as kuleana land in</u> <u>accordance with section 3.48.554.</u>"

SECTION 3. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 4. This ordinance takes effect upon its approval.
