SUBJECT: WAIALE ROAD EXTENSION PROJECT (LU-58)

Thank you for your letter dated July 2, 2018 asking for information about the above-referenced matter. We apologize for the delay in responding.

The Waiale Road Extension involves more than Condition 3(a) of Ordinance No. 2053 (1991). We believe that compliance with Condition 3(a) has been achieved; it required the applicant to fully fund, construct and improve the extension of Waiale from Mahalani Street to Honoapiilani Highway. Mahalani connects to Waiinu Road, which connects to Waiale, which extends to Honoapiilani Highway via either Kuikahi Drive or East Waiko Road.

Condition 3(e), however, required the applicant to contribute its pro-rata share of the costs to plan and construct a future bypass south of the above-referenced extension. It is not clear if this requirement has been fulfilled, and what the pro-rata share would entail. Condition 2 required the applicant to submit a twenty-year master plan for traffic improvements to the Director of Public Works; this presumably would have addressed, to some degree, how this condition would be fulfilled. Further research, including coordination with the Department of Public Works and the applicant's successor, would need to be conducted to confirm the status of compliance with Conditions 2 and 3(e).

We understand that you have posed a similar question to the Department of the Corporation Counsel, who has reviewed the project files and is preparing a more detailed response. As you know, we are meeting with the Department of Public Works, the State
