BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5217, Bill No. 46 (2021), Draft 1, as amended, "Fiscal Year 2022 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2022, is hereby amended as it pertains to the Emergency Management Agency, by adding a new grant entitled "Hazard Mitigation Grant Program (HMGP)" in the amount of \$108,997, to read as follows:

"1. Emergency Management Agency

a. Emergency Management Performance Grant (EMPG)	125,000
b. State Homeland Security Grant (SHSG) Program	1,000,000
c. Federal Emergency Management Agency (FEMA) Public Assistance Grant	8,000,000
d. <u>Hazard Mitigation Grant Program (HMGP)</u>	<u>108,997</u> "
