Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on August 18, 2021, makes reference to County Communication 21-46, from Council Chair Alice L. Lee, relating to litigation matters.

By correspondence dated July 15, 2021, the Department of the Corporation Counsel requested consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF JOHN MULLEN CLAIM NO. 4070387 OF SANDY FAROWICH."

The purpose of the proposed resolution is to authorize the Department to settle the claim for \$11,935.47 under terms stated in the resolution.

The Department also transmitted a copy of the claim and documentation relating to the claim.

Your Committee notes the claim, filed on May 19, 2021, alleges damages to the Farowich's property located at 2250 Kanakanui Road, Kihei, Maui, Hawaii, on May 5, 2021, resulting from a broken water main.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the claim. He said the incident occurred when a County of Maui water main broke and flooded the property.
