RELATING TO THE APPOINTMENT OF STACEY LEE VINORAY TO THE REAL PROPERTY TAX REVIEW BOARD

WHEREAS, by correspondence dated August 18, 2021, Mayor Michael P. Victorino notified the Council he nominated Stacey Lee Vinoray to the Real Property Tax Review Board for a term expiring on March 31, 2026, to fill a vacancy replacing Russell Johnson, in accordance with Sections 2.40.170 and 3.48.620, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and

WHEREAS, Section 13-2 of the Charter requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Stacey Lee Vinoray to serve on the Real Property Tax Review Board for a term expiring March 31, 2026;
2. That the Council expresses its gratitude and appreciation to Stacey Lee Vinoray for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
