

# A BILL FOR AN ORDINANCE AMENDING SECTION 16.16B.R401.2, MAUI COUNTY CODE, RELATING TO ENERGY CODE COMPLIANCE FOR LARGE RESIDENTIAL BUILDINGS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 16.16B.R401.2, Maui County Code, is amended to read as follows:

### "16.16B.R401.2 - Subsection R401.2 amended.

Subsection R401.2 of the International Energy Conservation

Code is amended to read as follows: R401.2 Compliance. [Projects

shall] New residential buildings over five thousand square feet must

achieve a maximum energy rating index (ERI) score of zero, and

projects must comply with one of the following:

- 1. Sections R401.3 through R404.
- 2. Sections R405 and the provisions of Sections R401 through R404 labeled "Mandatory."
- 3. An energy rating index (ERI) approach in Section R406.
- 4. The tropical zone requirements in Subsection R401.2.1."

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring. SECTION 3. This Ordinance takes effect upon its approval.
