BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5217, Bill No. 46 (2021), Draft 1, as amended, "Fiscal Year 2022 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2022, is hereby amended as it pertains to the Department of Finance, by adding a new grant entitled "American Rescue Plan Act of 2021, Non-Entitlement Units of Local Government (NEUs)" in the amount of \$17,523,295 and by adding 1.0 equivalent personnel, to read as follows:
