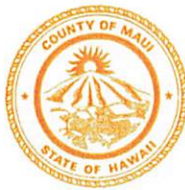

Pursuant to Section 2.41.090.E, Maui County Code, I am submitting a copy of a letter from the Chair of the Maui County Council on Aging regarding the lack of meeting attendance of Vivian Lindsey.

Ms. Lindsey was appointed by the Maui County Council on March 10, 2017 to the Maui County Council on Aging. The Council on Aging meets virtually a total of six times on the second Tuesday of each even-numbered month each year. Ms. Lindsey has been absent without excuse from all meetings from February 2021 to present (4 absences). Numerous attempts via telephone calls and emails were made with no response. ## REMOVAL OF VIVIAN LINDSEY FROM COUNCIL ON AGING FOR THE COUNTY OF MAUI

WHEREAS, by letter dated September 14, 2021, Mayor Michael P. Victorino recommended the removal of member Vivian Lindsey from the Council on Aging for the County of Maui due to her non-attendance at any meetings this year; and

WHEREAS, Ms. Lindsey was asked by staff to confirm whether she could continue on the Council on Aging for the County of Maui, and to date, staff has not heard from Ms. Lindsey, attached hereto as Exhibit "1"; and

WHEREAS, Ms. Lindsey was appointed to the Council on Aging for the County of Maui by Resolution 17-36, adopted on March 10, 2017, for a term expiring on March 31, 2022; and

WHEREAS, Section 13-2(5) of the Revised Charter of the County of Maui (1983), as amended, provides that members of boards and commissions appointed by the Mayor, with the approval of the Council may be removed for cause upon recommendation of such removal by the Mayor and the approval of two-thirds of the entire membership of the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby approves the removal of Vivian Lindsey from the Council on Aging for the County of Maui;
2. That such removal shall be effective upon adoption of this resolution; and

Dear Mayor Victorino,

As Chair of the Maui County Council on Aging, I am writing on behalf of the Council to inform you of the lack of meeting attendance by Council on Aging Members Agnes Groff & Vivian Lindsey.

Pursuant to Chapter 2.41.090 of the Maui County Code; "Attendance at board, commission, and committee meetings by appointed members", appointed members of all boards, commissions, and committees are responsible to "fully and faithfully serve and attend all duly noticed, regularly scheduled meetings of their respective boards, commissions, and committees".

Currently, the Council on Aging meets virtually a total of six times on the second Tuesday of each even-numbered month (February, April, June, August, October and December).

Unfortunately, Ms. Groff & Ms. Lindsey have not been fulfilling their responsibility to the Council on Aging, to you as your appointee, or the citizens of Maui County. Council Member Groff has been absent without excuse from all meetings from April, 2021 to present. Council Member Lindsey has been absent without excuse from all meetings from February, 2021 to present.

Despite numerous attempts to contact Ms. Lindsey and Ms. Groff, both have not responded to either emails or phone calls. Therefore, as Chair of the Maui County Council on Aging, I am recommending that both Agnes Groff & Vivian Lindsey be relieved of their duties as Council Members and replacement Council Members be recommended and appointed as soon as possible.

On behalf of the Council on Aging, I appreciate your consideration of this request and hope that replacements can be found expeditiously.
