Under Section 13-2 (5) of the Revised Charter of the County of Maui, I would like to formally request this matter be sent to the appropriate committee for consideration to remove Ms. Leinaala Perry from the Board of Water Supply. My request to remove Ms. Perry is based on the following:

Ms. Perry was approved by the Maui County Council on May 7, 2021 to the Board of Water Supply. The board staffer tried to contact Ms. Perry to inform her of this approval and could not get in touch with her. Numerous attempts via telephone calls and emails were made to her with no response. Ms. Perry has not responded or submitted any paperwork and therefore did not attend any Board of Water Supply meetings. Attached is a proposed resolution to remove Ms. Perry.

WHEREAS, by letter dated September 22, 2021, Mayor Michael P. Victorino recommended the removal of member Leinaala Perry from the Board of Water Supply for the County of Maui due to her non-attendance at any meetings this year; and

WHEREAS, Mr. Copeland was asked by staff to confirm whether she could continue on the commission, and to date, staff has not heard from Ms. Perry, attached hereto as Exhibit "1"; and

WHEREAS, Ms. Perry was appointed to the Board of Water Supply for the County of Maui by Resolution 21-75, adopted on May 7, 2021, for a term expiring on March 31, 2026; and

WHEREAS, Section 13-2(5) of the Revised Charter of the County of Maui (1983), as amended, provides that members of boards and commissions appointed by the Mayor, with the approval of the Council may be removed for cause upon recommendation of such removal by the Mayor and the approval of two-thirds of the entire membership of the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby approves the removal of Leinaala Perry from Board of Water Supply for the County of Maui


2. That such removal shall be effective upon adoption of this resolution; and
