## A BILL FOR AN ORDINANCE AMENDING TITLE 9, MAUI COUNTY CODE, TO ESTABLISH A FUNDAMENTAL RIGHT TO HOUSING

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. This Ordinance's purpose is to implement the following

General Plan policy, found at page 58 of the Countywide Policy Plan: "Recognize

housing as a basic human need, and work to fulfill that need."

SECTION 2. Title 9, Maui County Code, is amended by adding a new

chapter to be appropriately numbered and read as follows:

## "Chapter 9.38

## **RIGHT TO HOUSING**

Sections:

9.38.010	Applicability.
9.38.020	Right to housing.
9.38.030	Administrative rules.

**9.38.010 Applicability.** This chapter applies to all Maui County residents.

**9.38.020 Right to housing.** The fundamental human right to housing is declared to exist in Maui County. This right ensures access to adequate housing for all Maui County residents. This right is exclusively enforceable by a public right of action. It is the shared obligation of the County and its agencies to respect, protect, and fulfill this right through progressively implemented measures, consistent with available resources, within an aggressive, but reasonable, time frame.

**9.38.030 Administrative rules.** The director of housing and human concerns must adopt administrative rules to implement this chapter's provisions."

SECTION 3. This Ordinance takes effect upon approval.
