A BILL FOR AN ORDINANCE AMENDING SECTION 2.82.050, MAUI COUNTY CODE, RELATING TO GREENPRINT

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 2.82.050, Maui County Code, is amended to read as follows:

**"2.82.050 Greenprint.** [Utilizing] <u>Using</u> public outreach, the general plan, and other community and documentary resources, including land conservation organizations, a comprehensive conservation plan, also known as a greenprint, [shall] <u>must</u> be created [which] <u>that</u> includes a geographic information systems map. The greenprint [shall] <u>will</u> guide land acquisition by the County for open space, natural resources, cultural resources, and scenic views preservation purposes, and help to identify lands suitable for voluntary private-sector conservation. [The] <u>A proposed</u> greenprint [shall] <u>must</u> be adopted by the committee and submitted to the council by [January 1, 2021.] <u>December 31, 2022.</u> The committee [shall] <u>must</u> oversee the review and update of the [Countywide] greenprint, which [shall] <u>must</u> be submitted to the council every five years [thereafter].

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

## SECTION 3. This ordinance takes effect on approval.
