RELATING TO THE APPOINTMENT OF ARNOLD WUNDER TO THE CIVIL SERVICE COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated September 30, 2021, Mayor Michael P. Victorino notified the Council that he nominated Arnold Wunder to the Civil Service Commission for a term expiring March 31, 2024, to fill a vacancy replacing Blake Takayama, in accordance with Hawaii Revised Statutes Sections 76-71 and 76-47, and Sections 8-9.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

- 2. That the Council expresses its gratitude and appreciation to Arnold Wunder for his willingness to be considered for public service and actively participate in County government; and
