We would like to ask that we be permitted to finish them.

We have cancelled anything beyond August since we feel people will have time and resources to find a new venue for those ones.

I do want to point out a few things:

- The planning department and all other departments of the county including the building department
 have finished their investigation of our farm. We had no building permit violations at all and after both RVs
 were removed from the farm, we are now 100% compliant in all aspects. All county personnel told us that
 they would close the RFS.
- 2. We did not have any events at all in August, 2021. In September, we did not have 6 weddings either. Some of those were just group farm tours. Some were sunset farm tours with a meal afterwards and some were a group zipline and aquaball tour with a meal.
- 3. We did not have any events in November, 2021 either and also no events booked in March, 2022. We do not intent to book any more from now on.
- 4. Due to the pandemic, most of our wedding clients are going through very difficult times. They cancel, then rebook and then cancel and rebook due to constant rule changes. With ultimate compassion, we tried to work with them. We had no weddings in year 2020 and only started to host again this April. Our total event count will be under 24 for year 2021.
