CLERK, PLEASE PROCEED WITH ROLL CALL, AND THE GREETING FOR TODAY IS ACORI FROM SOUTH AFRICA. >> THANK YOU, CHAIR, PROCEEDING WITH ROLL CALL, MEMBERS PARTICIPATING FROM NON-PUBLIC LOCATIONS SHOULD STATE WHO IF ANYONE EXCEPT MINORS IS PRESENT WITH THEM AS PART OF ROLL CALL. NICE TO BE HERE, AND STAFF HAS MENTIONED THERE ARE NO TESTIFIERS AT THE HANA DISTRICT OFFICE.\r\n\r\n>> COUNCIL CHAIR ALICE LEE. >> HERE. I WISH EVERYONE ACORI FROM SOUTH AFRICA. AND WE'RE READY TO GO. THANK YOU. MADAME CLERK . >> THANK YOU, CHAIR. PRESENTLY THERE ARE EIGHT MEMBERS PRESENT.\r\n\r\nONE MEMBER, COUNCIL MEMBER PRO TEMPORE TASHA KAMA, IS EXCUSED A QUORUM IS PRESENT TO CONDUCT THE BUSINESS OF THE COUNCIL. I'M DEPUTY COUNTY CLERK RICHELLE THOMPSON AND ALSO PRESENT, MOANA LUTEY, JOYCE MURASHIGE AND LAUREN SALDANA AND DELL YOSHIDA AND JOINING THE MEETING IS COUNCIL SERVICES DIRECTOR DAVID RAATZ AND FIRST DEPARTMENT CORPORATION COUNSEL SONYA TOMA. >> AND DIRECTOR TRACI FUJITA IS ALSO PRESENT. >> THANK YOU. CHAIR. >> ALL RIGHT. OPENING REMARKS WILL BE PROVIDED BY COUNCIL MEMBER GABE JOHNSON. >> THANK YOU, CHAIR.\r\n\r\nGOOD MORNING, CHAIR, AND COUNCIL MEMBERS. I'M ALWAYS HAPPY TO START OUR MEETINGS WITH OPENING REMARKS, BECAUSE I BELIEVE IT'S IMPORTANT TO USE OUR BULLY PULPITS WHEN WE CAN AND SPEAK ON ISSUES IMPORTANT TO OUR COMMUNITY. WE OFTEN HEAR THAT JOBS THAT WE HAVE JUST AREN'T CUTTING IT. OUR YOUNG ADULTS ARE LEAVING AND TOURISM INDUSTRY HAS IS DESCRIBED AS EXTRACTIVE TO OUR RESOURCES AND OUR PEOPLE. WELL, AS CHAIR OF THE ADEPT COMMITTEE. I'M LASER-FOCUSED ON HELPING US BRING DIVERSITY TO OUR ECONOMY. AND NOT PUT ALL OUR GOLDEN EGGS IN ONE PROVERBIAL BASKET. I JUST CAME BACK FROM SET OF SHOW CALLED "MOKU MOKU," THEIR FIRST DAY SHOOTING AFTER THEIR PILOT AND LET ME JUST TELL YOU ARE THEY ARE COOKING UP SOMETHING GOOD AND I CAN'T WAIT FOR US TO SEE "MOKU MOKU "STREAMING LIVE IN OUR LIVING ROOMS.\r\n\r\nARTS ARE A GOOD WAY TO CREATE GOOD-PAYING JOBS THAT HAVE A LIGHT FOOTPRINT ON OUR ISLANDS AND GIVE US SOMETHING TO TALK-STORY OVER AND DEEPEN OUR TIES AND HISTORY AND VISIONS FOR THE FUTURE. THE STATE OF HAWAI'I GIVES A 27% TAX BREAK ON ALL PRODUCTION EXPENDITURES PER THE STATE OF HAWAI'I FILM OFFICE. THIS IN TURN ATTRACTS LARGE FILM PROJECT FROM HOLLYWOOD AND AS WE SEEN WITH THE ONGOING WRITER STRIKES WE CAN'T DEPEND ON A CENTRALIZED MODEL TO TELL THE STORIES OF OUR COMMUNITIES, NOR SHOULD WE. I WOULD LIKE TO ENCOURAGE MORE LOCALLY- BASED FILM AND ARTS. IN OUR COUNTY, FILM FESTIVALS, AKAKU, INDEPENDENT FILMS, UH MAUI COLLEGE MURALISTS, COMIC BOOK ARTISTS, WRITERS, CREATORS AND YOUTH-BASED ORGANIZATIONS, LIKE, STEM WORKS, AND MAUI HULI FOUNDATION ARE ALL AT THE READY FOR GROWING -- FOR A GROWING PLACE-BASED STORY- TELLING CREATIVE INDUSTRY. WE HAVE

APPROVED PUBLIC FUNDING INCLUDING ARTS AND CULTURAL GRANTS THAT ARE IMPORTANT INVESTMENTS TO SUPPORT EDUCATION, RENTAL EQUIPMENT, AND OTHER NEEDS OF OUR LOCAL CREATORS AND GO ON NETFLIX AND WATCH FILMS THAT AREN'T HOLLYWOOD SENT RICK AND THEY HAVE BEEN TAKING THEIR SHARE OF MARKET. IT'S TIME FOR US TO START TELLING OUR STORIES, FILM DOCUMENTARIES, TV SHOWS AND ARTWORK MADE BY RESIDENTS ABOUT HAWAI'I LIFE TELLING HAWAI'I STORIES THAT WILL BRING THE CULTURE AND ENVIRONMENTAL STEWARDSHIP TO THE FOREFRONT, THEREBY LIFTING UP OUR COMMUNITY, CREATING IDENTITIES, DEEPENING CONNECTIONS, AND SHARING HAWAII'S UNIQUE PERSPECTIVE.\r\n\r\nGIVE THE MIC TO THE LOCAL PEOPLE OF HAWAI'I AND MAUI COUNTY. THEY HAVE A GREAT LEGACY TO SHARE WITH REST OF THE WORLD. MAHALO, CHAIR. I YIELD THE FLOOR. >> THANK YOU. ONE, I THINK EVERYONE RECEIVED AN EMAIL FROM A COMMUNITY MEMBER, WHO REGULARLY TESTIFIES SAYING THAT SHE WASN'T AWARE THAT A COUNCIL MEETING WAS ON A TUESDAY, WHICH IS HIGHLY IRREGULAR, WHICH WE ALL KNOW WHY WE'RE DOING IT, BUT I GUESS, WE SHOULD PROBABLY BE A LITTLE MORE MINDFUL OF MAYBE PUTTING OUT PRESS RELEASES TO LET THEM KNOW THAT UNLIKE HOW WE USUALLY DO IT ON FRIDAYS, WE'RE HAVING OUR COUNCIL MEETING TUESDAY, BECAUSE OF CONFERENCES, AND BECAUSE OF THE BUDGET TIMELINES, AND THESE ARE THE REASONS, AND WE'RE NOT TRYING TO HIDE ANYTHING OR STIFLE TESTIMONY IN ANY WAY. SO FOR THOSE WATCHING NOW, AND A RECORDING LATER, THE NEXT COUNCIL MEETING WILL AGAIN BE ON A TUESDAY. SO PREPARE FOR THAT, SO YOU CAN COME OUT AND TESTIFY. BECAUSE WE DIDN'T HAVE ANY TESTIMONY TODAY, BUT WE ALSO DIDN'T HAVE ANYTHING CONTROVERSIAL AND NOTHING -- IT WAS ALL A LOT OF REALLY GOOD STUFF. SO THIS IS WHAT CAN HAPPEN WHEN THERE'S A LOT OF PEOPLE THAT JUST AGREE, WE CAN HAVE QUICK MEETINGS. I DON'T EXPECT ANOTHER QUICK MEETING ON THE 23RD. MAHALO, CHAIR. >> THANK YOU. YOU'RE ABSOLUTELY RIGHT. THE NEXT MEETING IS NOT GOING TO BE LIKE THIS. SO BRING YOUR BLANKETS AND PILLOWS [LAUGHTER], BECAUSE YOU KNOW AT FIRST READING FOR BUDGET, IT'S GOING TO BE A LONG ONE.\r\n\r\nA LOT OF LAST-MINUTE REVISIONS, AND SO FORTH. BECAUSE WE HAVE TO MAKE SURE THE BUDGET IS BALANCED AND WE'RE TALKING ABOUT A BILLION DOLLARS, YOU KNOW? IMAGINE THAT IN YOUR CHECKBOOK, TRYING TO BALANCE THAT? YES, VICE-CHAIR SUGIMURA, NOW WE'RE MAKING THE MEETING VERY LONG. HOURS IT CAN GO TO MIDNIGHT, WHICH I'M GLAD WE DIDN'T DO THAT EITHER. WE HAD GO DAYS -- TWO BUDGET MEETINGS THAT WENT ON PAST 5 O'CLOCK, BUT EVERYBODY DID VERY WELL. I DO FEEL WE CAN DO BETTER. I'M LOOKING TO PASSING THIS BUDGET ON THE 23RD, HOPEFULLY, FIRST READING, AND THEN ON JUNE 8TH IS GOING TO BE OUR SECOND AND FINAL READING, OF WHICH WE'RE MEETING THE CHARTER AMENDMENTS OF JUNE 10TH WE HAVE TO PASS THIS BUDGET. >>OKAY, ARE YOU SAYING YOU WANT LONGER MEETINGS?\r\n\r\nIS THAT WHAT YOU ARE SAYING? >> NO, LESS DAYS, NOT LONGER MEETINGS. >> OKAY. >> I HOPE SO. >> I COULD SEE FEWER DAYS.
