COMMUNITY PLAN AMENDMENT, DISTRICT BOUNDARY AMENDMENT, AND CHANGE IN ZONING FOR THE NAHIKU COMMUNITY CENTER (HANA) (PSLU-32)

The Committee is in receipt of County Communication 19-145, from the Planning Director, transmitting the following:

- 1. A proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND THE STATE LAND USE DISTRICT CLASSIFICATION FROM AGRICULTURAL TO RURAL FOR PROPERTY SITUATED AT NAHIKU ROAD, HANA, MAUI, HAWAII, TAX MAP KEY (2) 1-2-002:023." The purpose of the proposed bill is to grant a District Boundary Amendment from Agricultural to Rural for 1.9 acres located at Nahiku, Hana, Maui, Hawaii, identified for real property tax purposes as (2) 1-2-002:023, for the proposed Nahiku Community Center.

A proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND THE HANA COMMUNITY PLAN AND LAND USE MAP FROM AGRICULTURE TO PUBLIC/QUASI-PUBLIC FOR PROPERTY SITUATED AT NAHIKU ROAD, HANA, MAUI, HAWAII, TAX MAP KEY (2) 1-2-002:023." The purpose of the proposed bill is to grant a Community Plan Amendment from Agriculture to Public/Quasi-Public for real property identified for tax purposes as (2) 1-2-002:023 for the proposed Nahiku Community Center.

A proposed bill entitled "A BILL FOR AN ORDINANCE TO CHANGE ZONING FROM AGRICULTURAL TO P-1 PUBLIC/QUASI-PUBLIC FOR PROPERTY SITUATED AT NAHIKU ROAD, HANA, MAUI, HAWAII, TAX MAP KEY (2) 1-2-002:023." The purpose of the proposed bill is to grant a Change in Zoning from Agricultural to P-1 Public/Quasi-Public for real property
