The Committee is in receipt of the following:

- 1. County Communication 17-240, from the Planning Director, transmitting a proposed bill to grant a request from Jeana Iwalani Naluai for a five-year Conditional Permit to conduct classes in Hawaiian cultural and medicinal practices and operate a spa and bathhouse at 1550 Piiholo Road, Makawao, Maui, Hawaii.

Correspondence dated August 31, 2017, to the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE GRANTING JEANA IWALANI NALUAI A CONDITONAL PERMIT TO CONDUCT CLASSES IN HAWAIIAN CULTURAL AND MEDICINAL PRACTICES, AND OPERATE THE HO'OMANA SPA AND BATHHOUSE, ON PROPERTY IDENTIFIED AS TAX MAP KEY (2) 2-4-013:142, MAKAWAO, MAUI, HAWAII."
