**AMENDMENTS TO THE RESIDENTIAL WORKFORCE HOUSING POLICY (PROPOSED AMENDMENTS RELATING TO CREDITS, RESTRICTIONS FOR RENTAL UNITS, AND VACANCIES IN RESIDENTIAL WORKFORCE HOUSING UNITS) (HHT-2(1))**

The Committee is in receipt of the following:

1. County Communication 16-132, from Councilmember Stacy Crivello, relating to amendments to the Residential Workforce Housing Policy.
2. Correspondence from the Director of Housing and Human Concerns, dated August 8, 2016, transmitting a proposed bill amending Chapter 2.96, relating to the Residential Workforce Housing Policy.
3. Correspondence dated August 10, 2017, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.96, MAUI COUNTY CODE, RELATING TO RESIDENTIAL WORKFORCE HOUSING POLICY." The purpose of the revised proposed bill is to amend Chapter 2.96, Maui County Code, as it relates to: (1) Section 2.96.050A relating to credits; (2) Section 2.96.070 relating to residential workforce housing restrictions for rental units; and (3) Section 2.96.100(D) relating to vacancies in residential workforce housing units.

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of the correspondence and other related action.
