## NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (MAUI REDEVELOPMENT AGENCY) (PEA-2(3))

The Committee is in receipt of correspondence dated April 5, 2017, from the Mayor, transmitting a proposed resolution entitled "APPOINTMENT OF A MEMBER TO THE MAUI REDEVELOPMENT AGENCY," along with a completed application form for the nominee. The purpose of the resolution is to approve or disapprove the nomination of Gwen Hiraga to the Maui Redevelopment Agency, for a term expiring on March 31, 2022.

There is no time limitation for Council approval or disapproval of the nomination. The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.
