### **DONATION TO THE COUNTY OF MAUI, DEPARTMENT OF PARKS AND RECREATION, MAINTENANCE DIVISION, FROM BEYOND PESTICIDES FOR SOIL ANALYSIS AND REVIEW OF CURRENT TURF MAINTENANCE PRACTICES (PRL-23)**

The Committee is in receipt of the following:

1. County Communication 17-100, from the Director of Parks and Recreation, transmitting a proposed resolution to accept a donation for soil analysis and review of the Department of Parks and Recreation’s current turf maintenance practices.
