### CONTRACT NEGOTIATIONS AND COST ITEM PROPOSALS (COST ITEM PROPOSALS) (BARGAINING UNIT 12, STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS) (BF-6(2))

The Committee is in receipt of the following:

1. County Communication 17-467, from the Mayor, transmitting the following:
  - a. A proposed resolution to approve cost items for Bargaining Unit 12, included and excluded employees, represented by the State of Hawaii Organization of Police Officers, for Fiscal Years 2018, 2019, 2020, and 2021.
  - b. A copy of the interest arbitration panel’s decision and award dated November 7, 2017.
