AMENDING FISCAL YEAR 2017 BUDGET: APPENDIX C - CAPITAL IMPROVEMENT PROJECTS (DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, DEPARTMENT OF PARKS AND RECREATION, DEPARTMENT OF PUBLIC WORKS, DEPARTMENT OF WATER SUPPLY) (BF-22)

The Committee is in receipt of the following:

- 1. County Communication 17-38 from the Budget Director, transmitting a proposed bill to amend the Fiscal Year 2017 Budget, Appendix C, Capital Improvement Projects, by expanding the project descriptions provided for each Capital Improvement Project by adding "design" or "construction" to various descriptions for the Department of Environmental Management, Department of Parks and Recreation, and Department of Public Works.
- 2. Correspondence dated February 3, 2017, from the Budget Director, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, DEPARTMENT OF PARKS AND RECREATION, DEPARTMENT OF PUBLIC WORKS, DEPARTMENT OF WATER SUPPLY." The purpose of the revised proposed bill is to expand various project descriptions, including the Department of Water Supply.

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of County Communication 17-38 and other related action.
