NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (MOLOKAI PLANNING COMMISSION) (PEA-2(19))

The Committee is in receipt of correspondence dated and received on November 24, 2017, from the Acting Mayor, transmitting a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF LEONORA ESPANIOLA TO THE MOLOKAI PLANNING COMMISSION," along with a completed application form for the nominee. The purpose of the proposed resolution is to approve or disapprove the nomination of Leonora Espaniola to the Molokai Planning Commission, for a term expiring on March 31, 2021, to fill a vacancy due to the resignation of Robert Stephenson.

The Council must approve or disapprove the nomination of Leonora Espaniola by January 23, 2018, or the nomination will be deemed approved. The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.
