- 1. County Communication 17-260, from the Planning Director, transmitting the planning commissions' comments and recommendations on a proposed bill attached as Exhibit "1" to Resolution 16-93, to update the enforcement procedures for Bed and Breakfast Homes and Short-Term Rental Homes.
- 2. Correspondence dated April 25, 2018, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE COMPREHENSIVE ZONING ORDINANCE RELATING TO ENFORCEMENT PROCEDURES FOR BED AND BREAKFAST HOMES."
