**NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (VARIOUS) (PEA-2(26))**

The Committee is in receipt of the following:

1. Correspondence dated and received on January 26, 2018, from the Acting Mayor, transmitting a proposed resolution to approve or disapprove the nominations of Caryl Hitchcock-Sprinzel (Molokai) and Stuart Marlowe (Lanai) to the Urban Design Review Board for terms beginning on April 1, 2018 and expiring on March 31, 2023, along with completed application forms for the nominees.
2. Correspondence dated May 21, 2018, from the Department of the Corporation Counsel, transmitting a revised proposed resolution entitled "APPOINTMENT OF A MEMBER TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI."
