ESTABLISHING SHORT-TERM RENTAL HOMES AS AN AGRICULTURAL TOURISM ACTIVITY IN AGRICULTURAL DISTRICTS (LU-3)

The Committee is in receipt of County Communication 13-207, from former Councilmember Donald G. Couch, Jr. (Council Term 2013-2015), transmitting a proposed resolution entitled “REFERRING TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS A PROPOSED BILL AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO SHORT-RENTAL HOMES.” The purpose of the proposed resolution is to refer to the Lanai, Maui, and Molokai Planning Commissions, a proposed bill entitled “A BILL FOR AN ORDINANCE AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO SHORT-TERM RENTAL HOMES,” to provide for short-term rental homes as accessory uses in the Agricultural Districts.
