ELIMINATING EXEMPTIONS IN THE ELECTRICAL CODE, PLUMBING CODE, AND BUILDING CODE FOR CONSERVATION DISTRICT (IEM-9)

The Committee is in receipt of the following:

- 1. County Communication 13-135, from Councilmember Mike White, transmitting a proposed bill to eliminate exemptions in the Building Code of the County of Maui relating to lands within the Conservation District or lands designated as Hawaiian Home Lands.
- 2. Correspondence dated July 14, 2016, to the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTIONS 16.18B.090(2)(B), 16.20B.101.4.1, AND 16.26B.101, MAUI COUNTY CODE, TO ELIMINATE EXEMPTIONS IN THE ELECTRICAL CODE, PLUMBING CODE, AND BUILDING CODE OF THE COUNTY OF MAUI RELATING TO LANDS WITHIN THE CONSERVATION DISTRICT."
- 3. Correspondence dated July 20, 2016, from the Department of the Corporation Counsel, transmitting a revised proposed bill approved as to form and legality, entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 16, MAUI COUNTY CODE, TO ELIMINATE EXEMPTIONS IN THE ELECTRICAL CODE, PLUMBING CODE, AND BUILDING CODE OF THE COUNTY OF MAUI RELATING TO LANDS WITHIN THE CONSERVATION DISTRICT." The purpose of the revised proposed bill is to eliminate the exemptions in the Electrical Code, Plumbing Code, and Building Code of the County of Maui relating to lands within the Conservation District.

The Committee may consider whether to recommend passage of the revised proposed bill on first
