Victorino, transmitting a proposed resolution entitled "APPROVING FOR INCLUSION IN THE 2017 HAWAII STATE ASSOCIATION OF COUNTIES LEGISLATIVE PACKAGE A STATE BILL TO ALLOW CERTAIN GOVERNMENT RECORDS TO BE SHARED AMONG COUNCILMEMBERS WHERE NO COMMITMENT RELATING TO A VOTE ON THE MATTER IS MADE OR SOUGHT." The purpose of the proposed resolution is to approve for inclusion in the 2017 HSAC Legislative Package a proposed State bill, attached to the proposed resolution as Exhibit "A," entitled "A BILL FOR AN ACT RELATING TO GOVERNMENT RECORDS." The purpose of the proposed State bill is to allow certain government records to be shared among councilmembers where no commitment to vote on the matter is made or sought.

The purpose of the proposed State bill is to amend Section 89-6(2), Hawaii Revised Statutes, to provide the counties with a greater proportion of votes for collective bargaining units 11 and 12 for firefighters and police officers, respectively.
