**MAUI COUNTY LEGISLATIVE PACKAGE (2017 MAUI COUNTY LEGISLATIVE PACKAGE) (PIA-4(2))**

The Committee is in receipt of County Communication 16-248, from Councilmember Elle Cochran, transmitting a proposed resolution entitled “APPROVING FOR INCLUSION IN THE 2017 MAUI COUNTY LEGISLATIVE PACKAGE A STATE BILL TO RECOGNIZE NOVEMBER 28 AS LA KUOKOA, HAWAII’S INDEPENDENCE DAY.” The purpose of the proposed resolution is to approve for inclusion in the 2017 Maui County Legislative Package a proposed State bill, attached to the proposed resolution as Exhibit “A,” entitled “RELATING TO LA KUOKOA.” The purpose of the proposed State bill is to designate November 28 of each year as “La Kuokoa” to celebrate the historical recognition of independence for the Kingdom of Hawaii, but not construe the day as a State holiday.

The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider the filing of County Communication 16-248 and other related action.
