SPECIAL IMPROVEMENT DISTRICTS (EAR-36)

The Committee is in receipt of the following:

1. County Communication 15-165, from Council Chair Mike White, transmitting a proposed bill relating to special improvement districts.
2. Correspondence dated May 13, 2016, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 3,

MAUI COUNTY CODE, RELATING TO SPECIAL IMPROVEMENT DISTRICTS.” The purpose of the revised proposed bill is to authorize the County, by ordinance, to establish Special Improvement Districts to provide for and finance supplemental services and improvements.

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of County Communication 15-165 and other related action.
