### AMENDING THE FISCAL YEAR 2019 BUDGET: OPEN SPACE, NATURAL RESOURCES, CULTURAL RESOURCES, AND SCENIC VIEWS PRESERVATION FUND (MAKA`ALAE) (BF-183)

The Committee is in receipt of the following:

1. County Communication 18-369, from the Budget Director, transmitting a proposed bill to amend Appendix A, Part II, Special Purpose Revenues - Schedule of Revolving/Special Funds, Fiscal Year 2019, Open Space, Natural Resources, Cultural Resources, and Scenic Views Preservation Fund, by amending the proviso for a land appraisal for lots located in Maka`alae, Hana, Maui, by including additional lots identified as TMKs: (2) 1-3-007-024; (2) 1-4-007-005, 011, 012, and 019; (2) 1-4-010-014, 017, 027, 028, 029, 030, 032, 033, and 034; and (2) 1-4-012-022.
2. Correspondence dated November 1, 2018, from the Budget Director, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES - SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2019, OPEN SPACE, NATURAL RESOURCES, CULTURAL RESOURCES, AND SCENIC VIEWS PRESERVATION FUND." The purpose of the revised proposed bill is to amend Appendix A, Part II, Special Purpose Revenues - Schedule of Revolving/Special Funds, Fiscal Year 2019, Open Space, Natural Resources, Cultural Resources, and Scenic Views Preservation Fund, by amending the proviso for a land appraisal for lots located in Hana, Maui, by 1) including additional lots identified as TMKs: (2) 1-4-012-022, (2) 1-4-010-004, 008, 009, 010, 012, 014, 017, 027, 028, 029, 030, 032, 033, and 034; and (2) 1-4-007-001.

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of County Communication 18-369 and other related action.
