LICENSE TO ALEXANDER & BALDWIN, LLC, AS LICENSEE, AND DORIS TODD CHRISTIAN ACADEMY, AS SUBLICENSEE, FOR EXISTING ENCROACHMENTS ON COUNTY OF MAU REAL PROPERTY ALONG BALDWIN AVENUE (MAKAWAO) (LU-68)

The Committee is in receipt of the following:

- County Communication 18-315, from the Director of Public Works, transmitting a proposed resolution to authorize the grant of a license of County real property comprising approximately 5,600 square feet to Alexander & Baldwin, LLC as licensee and Doris Todd Christian Academy as sublicensee to accommodate existing encroachments immediately adjacent to sublicensee's property, identified for real property tax purposes as a portion of tax map key (2) 2-5-005:020 and tax map keys (2) 2-5-005:044 and :052, along a portion of Baldwin Avenue, Makawao, Hawaii, for an indeterminate length of time.
- 2. Correspondence dated October 1, 2018, from the Chair of the Committee to the Department of the Corporation Counsel, transmitting a revised proposed resolution entitled "AUTHORIZING THE GRANTING OF A LICENSE TO USE COUNTY OF MAUI REAL PROPERTY SITUATED AT MAKAWAO, MAUI, HAWAI'I TO ALEXANDER & BALDWIN, LLC, AS LICENSEE, AND TO DORIS TODD CHRISTIAN ACADEMY, AS SUBLICENSEE, FOR EXISTING ENCROACHMENTS ALONG A PORTION OF BALDWIN AVENUE." The revised proposed resolution incorporates nonsubstantive revisions.
