## APPOINTMENT AND REMOVAL OF ADMINISTRATIVE HEADS OF DEPARTMENTS (DIRECTOR OF HOUSING AND HUMAN CONCERNS) (GET-1(9))

The Committee is in receipt of the following:

1. Correspondence dated March 19, 2019, from the Mayor, transmitting a proposed resolution entitled "APPROVING THE MAYOR'S APPOINTMENT OF LORI ANN TSUHAKO FOR DIRECTOR OF HOUSING AND HUMAN CONCERNS." The purpose of the proposed resolution is to approve the appointment of Lori Ann Tzuhako as Director of Housing and Human Concerns, pursuant to Sections 6-2(5) and 8-10.2 of the Revised Charter of the County of Maui (1983), as amended ("Charter").
2. Correspondence dated March 21, 2019, from the Department of the Corporation Counsel, transmitting a proposed resolution entitled "DISAPPROVING THE MAYOR'S APPOINTMENT OF LORI ANN TSUHAKO FOR DIRECTOR OF HOUSING AND HUMAN CONCERNS." The purpose of the proposed resolution is to disapprove the Mayor's appointment of Lori Ann Tzuhako as Director of Housing and Human Concerns, pursuant to Charter Sections 6-2(5) and 8-10.2.

The Council must confirm or deny the appointment by May 18, 2019, or the appointment will be deemed confirmed. The Committee may consider whether to recommend adoption of the proposed resolution approving the appointment or the proposed resolution disapproving the appointment, with or without revisions. The Committee may also consider other related action.

With reference to this agenda item, one or more executive meetings are anticipated pursuant to Section 92-5(a)(2), Hawaii Revised Statutes, to consider the hire, evaluation, dismissal, or discipline of officers or employees.
