EXISTING STREETS (PSLU-49)

The Committee is in receipt of the following:

- 1. County Communication 19-228, from Councilmember Tamara Paltin, transmitting a proposed bill to require improvements to existing streets for subdivisions creating two developable lots.
- 2. Water and Infrastructure Committee Report 19-100, which was recommitted by the Council at its meeting of August 23, 2019.
- 3. County Communication 20-25, from Councilmember Tamara Paltin, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 18.20.040, MAUI COUNTY CODE, RELATING TO EXISTING STREETS." The purpose of the proposed bill is to require improvements to existing streets for subdivisions creating two developable lots.

The Committee may consider whether to recommend passage of the proposed bill noted in paragraph 3 on first reading, with or without revisions. The Committee may also consider the filing of County Communication 19-228, Committee Report 19-100, and County Communication 20-25, and other related action.
