## NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (VARIOUS) (GREAT-2(1))

The Committee is in receipt of the following:

1. Correspondence dated May 26, 2021 (received on May 27, 2021), from the Mayor, transmitting a proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE BOARD OF VARIANCES AND APPEALS FOR THE COUNTY OF MAUI," with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Ross Takashima to the Board of Variances and Appeals, for a term expiring on March 31, 2026.
2. Correspondence dated May 26, 2021 (received on May 27, 2021), from the Mayor, transmitting a proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE BOARD OF WATER SUPPLY FOR THE COUNTY OF MAUI," with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Juanita Reyher-Colon to the Board of Water Supply, for a term expiring on March 31, 2026.
