### CONSERVATION PLANNING COMMITTEE (GREAT-7)

The Committee is in receipt of the following:

1. County Communication 20-69, from Councilmember Michael J. Molina, relating to the Conservation Planning Committee.
2. Correspondence dated October 27, 2021, from Committee Chair Michael J. Molina, transmitting a proposed resolution entitled "APPOINTMENT OF MEMBERS TO THE CONSERVATION PLANNING COMMITTEE FOR THE COUNTY OF MAUI." The purpose of the proposed resolution is to appoint the Council's three voting members to the Conservation Planning Committee, for staggered terms of three years each: Mahina Poepoe (Moloka'i), Benjamin Ostrander (Lāna'i), and Samuel Akoi IV (East Maui Community Plan Area).

The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider the filing of County Communication 20-69 and other related action.
